

Kentucky Psychological Association Hall of Fame Awards

CALL FOR NOMINATIONS:

The KPA Past-President shall be responsible for assuring that a Call for Nominations occurs in the spring of each year via the Newsletter, emails and other announcements as indicated. Nominations can be made by any KPA member. A Nomination form will be available on the KPA website. The form will include eligibility and selection criteria, deadline for nominations, and a narrative statement as to why the nominee deserves induction.

ELIGIBILITY FOR NOMINATION:

1. Nominees shall be current or former KPA members.
2. Nominees shall have lived and worked in Kentucky for a significant portion of their career
3. Nominees shall have earned a graduate degree in psychology.
4. Nominees shall not have been sanctioned by the KBEP.
5. Nominees shall not be previous KPA Hall of Fame Award winners.
6. Nominations shall be submitted by current KPA members.

SELECTION COMMITTEE:

The KPA Executive Committee shall make the final selection of inductees. Reasonable attempts will be made to verify the accuracy of the nomination information, as well as determining if the nominees have ever been disciplined or sanctioned through action of the Kentucky Board of Examiners of Psychology.

SELECTION CRITERIA:

Selection of inductees shall be completed through consideration of the following criteria. A nominee need not meet all criteria, but should have made a significant contribution in at least one area listed.

1. Contributions in the field of psychology (in what way has the individual left an imprint in the field?)
2. Contributions to KPA's growth and development
3. Lifetime achievements as a psychologist
4. Contributions in service to the community, the Commonwealth or the nation
5. Demonstrated leadership in their specific field that contributes to the mental health of citizens in Kentucky
6. Innovative application of psychological knowledge such that the quality of life of Kentucky's citizens is enhanced
7. Contributions to the elevation of the status of psychology
8. Inspiration of others by their example
9. Contributions that increase the body of psychological knowledge
10. Contributions that enhance the quality of psychological service delivery

AWARDS PROGRAM:

The inductees to the KPA Hall of Fame will be announced each year at the Awards Program at the annual KPA Convention. Following the Convention, the Past-President will submit an article about the Award winners for publication in the KPA Newsletter. A plaque with the names of all KPA Hall of Fame Award winners will be maintained at the KPA Central Office.
